I hereby state that I have read, understood and answered honestly the Health Certification Document. I also state that I wish to participate in **“Corfu Outdoor & Leisure Activities”** excursions program which may include, but is not limited to, walking, hiking or cycling in altitude up to 930 m above sea level, Stand Up Paddling or Kayaking in sea water up to 10 m deep, cooking classes involving wood fire oven or use of LPG(gas) for cooking,(hereafter referred to as Activities). I realize that my participation in these Activities involves the risk of injury and even, the possibility of death. Furthermore, I hereby confirm that I am voluntarily participating in such Activities with knowledge of the dangers involved and that I expressly assume and accept sole responsibility for my own health and safety.

I declare myself physically and mentally sound and suffering from no condition, injury, impairment, disease, infirmity, or other illness that would prevent my participation in above activities. I recognize that it is my sole responsibility to obtain an examination by a doctor prior to involvement in these Activities(not prior than one year from the date of the Activity). I acknowledge that I have either had a physical examination and been given my doctor’s permission to participate or, I ACKNOWLEDGE I AM DOING SO AT MY OWN RISK.

In acknowledging that I am aware of and willing to assume and accept the risks associated with these Activities, I hereby voluntarily agree TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against **“Corfu Outdoor & Leisure Activities”** and its owners, employees, independent contractors, representatives, successors and assigns (all of whom are hereafter referred to as the “RELEASEES”) and to release the RELEASEES from any and all liability for any loss, damage, expense or injury, including death that I may suffer or my next of kin may suffer as a result of my participation in these Activities.

I understand that **“Corfu Outdoor & Leisure Activities”** do not employ professional guides/escorts and each guide/escort has their own liability insurance cover. As such, I understand and acknowledge that **“Corfu Outdoor & Leisure Activities”** accepts no responsibility for any loss, damage, or personal injury arising out of my acts, errors or omissions. This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Hellenic Republic and any litigation involving the parties to this Agreement shall be within the exclusive jurisdiction of the Courts of the Hellenic Republic.
